WHEN: Saturday, November 26, 2022, 9am-4pm, and Sunday, November 27, 2022, 11am-4pm

WHERE: Lucas County Recreation Center, 2901 Key St., Maumee, OH 43537

DEADLINE: October 23, 2022. However, **applications will be taken until the show is full.** A waitlist will be created for last-minute substitutions.

SET UP TIMES: Friday, November 25, 2022, 12noon-6pm, and Saturday, November 26, 2022, 7am-8:30am

NON-REFUNDABLE JURY FEE: \$20 for the first 3 categories **BOOTH FEE:** \$115-\$125 per space (approximately 10ft by 10ft)

SPACES: You will be responsible for making sure your preferred display setup fits into the space dimensions. Fire code regulations prohibit extending beyond your assigned space(s) and into the aisles.

ELECTRICITY: Electric will be limited to wall spaces and the spaces across the aisle from the wall. It will not be available in the three center aisles. Bring heavy-duty (14 gauge) extension cords. Cords cannot be taped to the floor. **The use of LED bulbs is highly recommended. Wattage available to each crafter may be limited to avoid tripping the circuit breakers.**

*****TABLES AND COVERS:** Table covers must be 100% polyester or other flame-retardant material. The color may be navy (preferred color), black, brown, burgundy/wine, grey, or hunter green. The Executive Board may approve other dark, solid, neutral colors at the request of a participant prior to the color being used at a show. The table cover must cover all sides of the table and must reach the floor. All demonstration/packing tables with open space under the tabletop must also be covered (i.e., no "naked" table legs unless table legs are decorative in nature (ex. wooden claw foot tables)). Additional tabletop covers/cloths (lace, draping) may not hang more than twelve (12) inches over the edge of the covered tables. You will be asked to correct any table coverings that do not meet these required standards. **A limited number of 8-foot table covers are available for rent for a nominal charge for the weekend on a first-come first-reserved basis. See page 2 of the application.**

AFTER THE SHOW: Double-check and clean up your space before leaving.

NON-MEMBER PARTICIPATION REQUIREMENTS: Failure to follow these rules will result in not being invited to participate in future shows.

- 1) Work that is submitted for jurying must be the original creation of the artist/craftsperson, must not be produced by employees, and be at least 70% handcrafted. No item may be mass-produced on a duplicating or copy machine. Original artwork may be professionally copied, but the items displayed may not comprise more than 20% of the booth display.
- 2) Items not accepted: commercial kits; plastic flower, fruits, or greenery; plastic needlepoint; quickie decoupage, mod podge, or poured finish; jewelry composed entirely of commercial findings and/or pre-cut stones; assembled items that are not 70% handcrafted; pom-pom, beaded items, and bazaar items; other items at the Jurying Committee's discretion
- 3) Participants must be set up 30 minutes prior to the show's starting time and remain set up until closing time. Packing and teardown will not begin until the show is officially over.
- 4) Food items may not be prepared at the show.
- 5) No use of radios or TV is allowed. Electronic devices may be used to show a participant's creative process or use of art.
- 6) All state and local smoking ordinances will be obeyed. Smoking, including electronic cigarettes, is permitted only in designated areas.
- 7) Items necessary for the sale of a craft (such as suction cups or belt buckles or necklace chains) may not be priced and sold separately.
- 8) Sale signs implying a price reduction are not permitted. "Seasonal" or "Discontinued" may be used as long as it says nothing about a price reduction.
- 9) Use of aerosol sprays, epoxy glues, etc., may only be used outdoors due to their strong odors and to protect floor surfaces.
- 10) Courteous behavior is expected of all show participants. Profanity (verbal or nonverbal) is not permitted.
- 11) Proper attire and footwear are required.

JURY PROCESS: Your art/craft must meet the same standards as if being juried for Guild membership set by the Jurying Committee. Each member of the Jurying Committee will evaluate your work for: Originality (1-5 points), Quality (1-10 points), and Appearance (1-5 points). The individual scores of the Jurying Committee will be averaged for a total score. You must receive a total score of at least 14 points to be considered for the show.

INCLUDE THE FOLLOWING WITH YOUR COMPLETED APPLICATION:

- A \$20 check for the first 3 categories in which you wish to be juried.
- One check for each 10'x10' space you wish to purchase (i.e., if you want 2 spaces, include 2 checks). Include the cost of table rental on a per-space basis.
- A minimum of 3-5 close-up photos of items that best represent each category selected (i.e., if you are being juried in 2 categories, you will include 6-10 photos)
- 2 photos of you making your product
- A photo of your booth display
- A short essay on how you create your product from start to finish
- A list of shows you have participated in
- Food vendors only: a copy of your Department of Agriculture certification either as a licensed Bakery or a Cottage Food Industry
- A self-addressed and stamped envelope or an email address to receive show set-up information or an email address

Confirmation that your application and information were received will be emailed to the email address you provide on your application.

No refunds will be given after the deadline if you are accepted into the show unless we can fill your space from a waitlist.

If for some reason you are unable to attend the show after you have been accepted into the show, please contact one of the following Co-Chairs. The Guild's By-Laws require show participants to notify the Chairpersons **prior to the show** if they cannot attend.
